Rules and Regulations

ALL VENDORS/EXHIBITS

1. Liability insurance in an amount not less than \$ 1,000,000.00 naming California International Airshow Salinas as additional insured
2. Seller's permit from the State Board of Equalization, www.stateboardofequalization.com.
3. Weights to keep canopy/ies or any type of set up in place.

4. You must supply your own tables, chairs, electrical power, coverage, tie downs, signage, etc.
5. No vehicles are allowed on the ramp during the show hours. All vehicles must be off the ramp by 8am.
6. You must provide proof of insurance with comprehensive liability insurance for any and all of the vendor/exhibit's activities pertaining to the Airshow adding California International AirShow Salinas as additional insured in an amount not less than \$1,000,000.00 in coverage.

Agreement

No products bearing California International Airshow, Salinas (CIAS) trademark, name or logo or reference to such may be sold or distributed without written permission from CIAS, Salinas Management. Show Management may eliminate or limit some of the items listed on your application to allow for a wide variety of displays and avoid duplication.

It is mutually agreed that this Agreement or the privileges granted herein, or any part thereof, cannot be assigned or otherwise transferred.

All vendors/exhibits shall comply with all city, county and state laws and hold all the licenses and permits required. Proper signage with prices is required as well as the acceptance of payment with card.

All vendors/exhibits are responsible for the people working or volunteering in their booth including Worker's Compensation for employees.

Booths are required to be clean and sanitary at all times. Hawking is prohibited. Only sell what has been approved on your application.

Vendors/exhibits need to have vehicles off the ramp 1 hour prior to the Airshow opening to the public and 1 hour after the Airshow is closed.

All vendors/exhibits will be responsible for any damage done to the tarmac at the Airport. This includes any grease or oil spills made during preparation and clean up. The CIAS has the right to charge the vendor/exhibit for any damage.

All vendors/exhibits are required to treat others and others' belongings with respect. If responsible for any damage or harm to others, others' property, or the airport facility, you will be required to pay for damage.

In the event vendor/exhibit staff fails to comply with any of the provisions of this Agreement, it shall forfeit all rights and CIAS shall have the right to occupy the booth in any manner deemed for the best interest of the Airshow. At this time vendor/exhibit staff may be asked to leave without a refund.
